- 3. Document Verification (DV) will be held at the premises indicated in the e-call letter for DV. After scheduling the candidates for DV, they will be sent an email and SMS to download e call letter over and above publishing the DV Schedule on RRBs websites. E-Call letter with details of date, time and session (FN/AN) along with the instructions for Document verification and Medical Examination can be downloaded from the websites of RRBs.
- 4. Candidates may note that after completion of DV, they will be sent for Medical Examination at the nominated Railway hospitals located in the jurisdiction of RRBs on the next day of DV. Accordingly, Candidates have to come prepared for DV and Medical examination.
- 5. The shortlisted candidates for DV should produce all the original documents along with two sets of Xerox copies in A4 size as detailed in the CEN and e-call letter.
- 6. Candidature of all the shortlisted candidates for Document verification is purely provisional and is liable to be cancelled, at any stage of recruitment or thereafter, in case of any inconsistency/deficiency in the data furnished by them in their online application or any malpractice on the part of candidates coming to the notice of RRB at any stage of the recruitment process. It may be noted that merely calling a candidate for Document Verification does not entitle him/her in any way to an appointment in the Railways.
