Document verification for various posts against CEN No. 02/2025- Technician Gr. (I & III)

1.0: Candidates bearing the Roll Numbers listed herein under have been provisionally shortlisted for the Document Verification (DV) for the posts notified in CEN No. 02/2025- Technician Gr. (I & III) based on their score in CBT. This list of shortlisted candidates for DV is drawn equal to the vacancies published on the websites of RRBs, subject to availability of eligible candidates.

2.0: Document Verification (DV) will be held For Technician Gr.I on **29.07.2026 & Technician Gr. III on 29.07.2026, 30.07.2026 & 03.08.2026 to 06.08.2026**. Reporting for DV is 09:30 AM. The roll number/ date of DV is published herewith. The candidates scheduled for DV will get an email and SMS to download their e-call letter from RRB Website. **Block date for absentee candidate will be 17.08.2026.**

Failure to report for document verification tantamount to rejection of candidature. In case the candidate is not able to attend for document verification on account of his/her appearing in a University / Govt. examinations or personal sickness, They are advise to :- (1) send intimation of his/her non reporting along with the reason to this office by Mail on scheduled date and time, and (2) report for the document verification on **Block date** at 09.30 AM along with documentary proof (as above) in support of his/her not having been able to attend the document verification on the schedule date and time, They should report with E-Call letter for DV already issued. No separate E-Call letter for the block date will be issued. The intimation for block date is already mentioned in the e-call letter issued to the candidates.

3.0: Candidates may note that after successful completion of DV, they have to undergo Medical Examination at the nominated Railway Hospitals located in the jurisdiction of RRB. The candidates are required to come prepared to stay for three to four days. Candidates have to pay the prescribed medical fee of Rs.24/-. Accordingly, candidates have to come prepared for DV and medical examination.

4.0: **The shortlisted candidates are advise to upload their documents, photo and signature and fill up the 2 mark of identifications on the portal of <https://oirms-ir.gov.in/rrbdv>. For DV, candidate should produce all the original documents along with 2 set of Xerox copies in A4 size as detailed in the CEN and e-call letter.**

5.0: Candidature of all the shortlisted candidates for Document Verification is purely provisional and is liable to be cancelled, at any stage of recruitment or thereafter, in case of any inconsistency / deficiency in the data furnished by them in their online application or any malpractice on the part of candidates coming to the notice of RRB at any stage of the recruitment process. It may be noted that merely calling a candidate for Document Verification does not entitle him/her in any way to an appointment in the Railways.

6.0: While every care has been taken in preparing the list of candidates shortlisted for Document Verification, RRB reserves the right to rectify any inadvertent error or typographical/printing mistakes. RRB regrets for the inability to entertain any correspondence from unsuccessful candidates.

7.0: Important: Beware of the touts who may misguide the candidates with false promises of getting them selected for the job on illegal consideration. The recruitment process in the RRB exams is fully computerised and the selection is based purely on the merit of the candidates.

8.0: Candidates are advised to regularly visit RRB's official website for the updates.

9.0: The Roll Numbers of provisionally shortlisted candidates for Document Verification are arranged horizontally in ascending order and not in the order of merit.
